The legal externship program at MC Law consists of three options: a three (3) hour local externship course, a three (3) hour remote externship course, and a six (6) hour remote externship course. All externship placements are with judicial chambers, government agencies or public interest organizations and are unpaid.

Externships are available to any student who has completed at least 45 academic credit hours. Generally, a student has sufficient academic credits to extern beginning in the spring semester of his or her 2L year.
